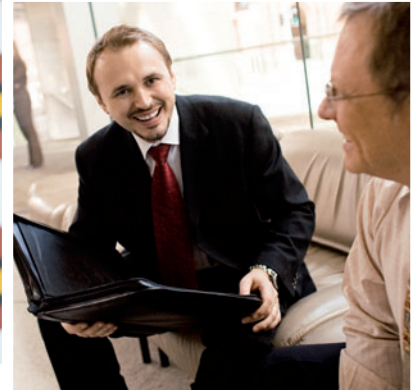


## Tough times... time to think **export**
